Golla is upset that the MF gym has not yet repainted to remove reference to the "Indians" name and makes it clear that the decision to change the nickname has already been made and that the school board has decided already.

Colleagues,

I am not sure how viable it is to still get the gym painted to remove the reference to our mascot. Rick shared that he is meeting with a contractor and I realize fall sports are beginning soon. I can't pretend I am not disappointed The gym was painted to its c111Tent state in one summe1· based on the unilateral decision of one leader at the site level acting in direct conflict with the district.

I will likely be giving my second public interview in t\VO days since the emergence of a resolution on the use of native american mascots today. This resolution is coming through the Wisconsin State School Board Association. They will be voting on a resolution to forward legislation to ban the mascot this fall. I doubt the law will pass but it brings this issue into the public eye and reflects poorly on us. In the Journal Sentinel yesterday I indicated that in our rebranding efforts we committed to minimizing the public reference of 0111· mascot on uniforms and in our facilities. We have our school board's support to do that and they are under the impression that it had been painted this summer. It was not an easy lift to get them to this point.

Today Channel 58 intends to inteview me. It would be a reasonable request of them to ask to get B video from our school. If I were them I would shoot the interview from the gym to fully project our hypocrisy

We now find ourselves in a position 1, where anything We do will appear to be done in response to public pressure rather than in the spirit of working toward removing a 1 eference that many find offensive. Inconveniencing teams will only exacerbate the ill will.

This matters. We can t on one hand teach students that it is harmful to hold stereotypes of people based on their race, 1·eligion, or culture and on the othe1· be 1·epresented by a mascot that, even though the intention \Vas 1·espectful, promotes a stereotype that Native Ame1icans fall under a common set of characteristics (honorable, stoic, fierce warrior, etc). We are promoting stereotypes and it is harmful. I have shared with the board that I am fine moving

slowly and carefully but I need to move on this issue. I need support.

I am sorry for the email on a sensitive topic where I am clearly frustrated but pulling the team together at this time of the year with all that is on your plate is not practical.
